Waiver, Indemnification, and Hold-Harmless Agreement for Hike

Waiver, Indemnification, and Hold-Harmless Agreement:

You are participating in a Meetup solely by your own choice and at your own risk. You will not hold the organizer, Hike For Beer, or anyone else liable for any injury to you or your property arising from or relating to your participation in today's Meetup, and you release, waive, discharge, and hold harmless any judgment, loss, injury, liability, cost, and expense (including, without limitation, attorney's fees) arising from or relating to your participation in a Meetup. Each person is solely responsible for their own conduct and outcomes. We must all understand that, 1) everyone participating should take responsibility to assist in creating a safe environment, and asking everyone to please read and agree to the waiver as you RSVP- Yes to any of our events.

Waiver:

In consideration of being permitted to participate in any way Hike For Beer's Hiking event, hereafter called "Event", I, for myself, my heirs, personal representatives, or assigns, do hereby release, waive, discharge, and covenant not to sue the Meetup organizers, volunteers, land owners, business owners, teachers, speakers, guides, or Meetup members for liability from any and all claims resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in Event.

Assumption of Risks:

Participation in Event carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from Event to Event, and range from minor injuries like paper cuts from handouts and sprained ankles from walking from your car to the event location or crossing creeks, climbing hills, walking on slick dirt, stepping over logs, negotiating steps and stairs, to major injuries like being struck by a car or breaking bones by a fall, to even catastrophic injuries like loss of sight, strokes, heart attacks, paralysis or death.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in Event, I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless:

I also agree to indemnify and hold harmless the Meetup organizers, volunteers, land owners, business owners, teachers, speakers, guides, and Meetup members from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees brought as a result of my involvement in Event and to reimburse them for any such expenses incurred.

Severability:

I further expressly agree that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State participating in and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding:

I understand this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge these terms by RSVPing "Yes" to a Meetup group Event. By my RSVP and by my attendance, I am agreeing freely and voluntarily to a complete and unconditional release of all liability to the greatest extent allowed by law.
